WAIVER AND RELEASE OF LIABILITY

In consideration of Family Shooting Centers, Inc. ("FSCI") furnishing services, equipment, and/or the facilities and in consideration of my participation in clay shooting and other related activities (the "Sport"); I agree as follows:

1. I fully understand and acknowledge that:

- (a) there are risks and dangers in my use of Sport equipment and my participation in the Sport;
- (b) my participation in the Sport, use of Sport equipment, and/or presence at FSCI's facilities may result in damage to or loss of personal property, personal injury, death, or other ailments that could cause serious disability;
- (c) these risks and dangers may be caused by the negligence of the shareholders, officers, directors, employees or agents of FSCI, the negligence of others, accidents, breaches of contract, forces of nature or other causes, and that risks and dangers may arise from foreseeable or unforeseeable causes, and;
- (d) I, on behalf of myself, my family, heirs, executors, administrators, representatives and assigns, assume all risks and dangers and all responsibility for any losses and/or damages which result from my participation in the Sport or presence in or on FSCI's facilities;
- (e) WE RECOMMEND TAKING INSTRUCTION OR GUIDES FOR ALL FIRST TIME AND BEGINNER SHOOTERS;
- (f) I HAVE READ AND UNDERSTAND THE COURSE RULES & POLICIES ON THE REVERSE SIDE.

I, for myself, my spouse, family, heirs, executors, administrators, legal representatives, and assigns, hereby release, waive, discharge FSCI, and its officers, shareholders, directors, employees, and agents (collectively, "Releases") from any and all claims, actions or losses for injuries, property damage, death, loss of services or other, arising out of my participation in the Sport or presence in or on FSCI's facilities, whether due to the fault or negligence of Releases, circumstances beyond Releases' control, or other.

LVSC Course Rules & Policies (partial list)

1. Protective glasses and ear protection must be worn on the shooting course at all times.
2. All guests must abide by all signage, rules, policies and regulations posted around the course at all times.
3. Guests may use their own shotguns, however, they must be a field/sporting shotgun with a barrel length of 24" or longer for a break action; or 20" or longer for a pump action or semi-automatic shotgun. No tactical, sawed-off barrels, collapsible stocks, homemade, and/or pistol grip shotguns allowed, unless they support a disabled guest. Convertible/combo/hybrid semi-auto/pump shotguns not allowed.
4. No picture taking from in front of the shooting stations! No drones are allowed at any time on the property for everyone's safety. Do not walk off the paved path for any reason, it is a target range, you may be shot.
5. Never enter or look into the opening of a trap house. Never try to fix a trap machine. Notify the LVSC staff at once of any problems or safety issues. Clubhouse phone number posted at each station.
6. No alcoholic beverages or recreational drugs are allowed prior or during shooting. No one will be allowed to participate in any shooting activity if deemed to be under the influence of alcohol or drugs.
7. All guest guns, gear, coolers, golf carts or ATVs may be subject to safety inspections.
8. A shotgun can only be loaded when a shooter is in the station, the gun is over the front rail and target area is deemed clear and safe. At all times, the gun shall be unloaded and placed on a rack or carried vertically with the action open. When leaving any station or shooting area, shooters must ensure that the shotgun is unloaded and the action is open and carried in a vertical position.
9. All shots must be taken from inside a station by one person at a time. Shooting from anywhere else including next to or in front of a station is strictly prohibited. ONLY wheel chair shooters are permitted to shoot directly next to a station when it is deemed safe.
10. No practice mounts or swings are allowed except while in the station and the gun pointed down range.
11. No more than TWO (2) shells in a shotgun. The largest shot size permitted is #7 ½ (i.e. #8, #9 allowed – **NO** #6 shot or larger). If found with larger shot, you will be asked to leave the course with no refund.
12. It is forbidden to shoot at any live game. If observed or reported you will be asked to leave the course with no refund and reported to the PA Game Commission for prosecution.
13. You must pick up your empty shotgun shell hulls safely after shooting at each station.
14. We are not responsible for any damages to your person, gun or any equipment that falls off of a push cart, golf cart or ATV for any reason, whether it's yours or LVSC's cart. All drivers of a golf cart/ATV, whether it is yours or LVSC's, must possess a valid automobile driver's license.
15. Guns carried on personal golf carts/ATVs must be carried vertically. We are not responsible for damages to personal golf carts/ATVs caused by our staff, other guests or the owner.
16. No golf cart/ATV speeding. Speeding is considered driving faster than a person jogging, or staff's judgment. Speeders will be asked to leave for the day with no refund, **NO WARNINGS!**
17. Only drive in a clockwise rotation. All golf cart riders must be seated. No hanging or standing on the back of a golf cart/ATVs. No more than four (4) riders per golf cart.
18. LVSC Management or Range Safety Officers (RSO) have the final determination on safety. Any infraction of our rules or regulations may result in loss of privileges and possible expulsion from the property with no refunds.
